Submission for Funding Allocation for a Public Toilet in the vicinity of the Torea Bay Jetty

This submission is made on behalf of the Kenepuru and Central Sounds Residents' Association.

The Association was established in 1991 and currently has approximately 200 household members whose residents live full time or part time in the Kenepuru and Pelorus Sounds. The Association's objects include, among others, to coordinate dealings with central and local government and promote the interests of residents of Kenepuru Sound and adjacent areas and to promote and act in the best interests of residents, ratepayers and persons associated with the Kenepuru and Central Sounds area. AGMs of the Association are well attended.

Submission

We refer to our correspondence and subsequent discussions with various Council Officers and Councilors in connection with the above.

The Association strongly believes that a public toilet facility located in reasonable proximity to the Torea Bay jetty is long overdue given the significant year round flow of people, vessels and vehicles to and from this busy jetty. We believe and submit that the case for this facility is clear.

Accordingly, the Association requests that the Marlborough District Council set aside in its funding programme a sufficient sum of money for the placement, construction and maintenance of a public toilet at the Torea Bay jetty.

The Association confirms and assures the Council that once such an allocation is made it would be pleased to support and assist the Council in the process of identifying an appropriate location and in the associated resource consent application.
